The terms & conditions for appointment of Junior Residents (MBBS) are as follows:-

- Qualification:-MBBS Degree from a recognized University/Institute approved by NMC.
- 2. DMC Registration:
- a) The candidate must be registered with Delhi Medical Council at the time of interview; or
- b) The candidates must be applied for DMC with proper acknowledgement at the time of interview, failing which the candidate will not be allowed to appear:
- c) The candidates, who have submitted receipt showing that they have applied for DMC registration at the time of interview, should submit valid DMC registration certificate at the time of joining.
- d) The above criteria may be subject to change depending on prevailing circumstances and the operational status of the DMC.
- 3. <u>Internship</u>: The candidates, who have completed internship before 08.08.2023 i.e. two years from the date of interview, are not eligible.
- Admissible Emoluments: Rs.56,100+NPA+other allowances in Pay Level-10 (Index-1) as admissible under the rules of 7<sup>th</sup> CPC.
- 5. Citizenship: The candidates should be Indian citizen.
- 6. Age limit: The age relaxation for SC/ST/OBC/PH candidates shall be applicable as per instructions of Govt. of India issued time to time. The age eligibility as on date of interview i.e. 08.08.2025 is given below:-

### 7. Relaxations, in case sufficient fresh candidates are not available:-

General Instructions regarding relaxation of provisions for residency scheme for the Junior Residents vide circular No. F.121/26/2010/H&FW/DSHFW-1996-2045 dated 10.06.2011 issued by the Deputy Secretary (H&FW), Health & Family Welfare Department, Govt. of NCT of Delhi are as under:



- a. Upper age limit for eligibility will be 40 years in place of existing 30 years of age.
- b. Post Graduates, who are interested to serve as Junior Resident, will be allowed to join as Junior Resident, if fresh graduates are not available.
- c. Junior Residents, who have completed one year of junior residency, may apply under relaxed criteria. There would be no extension for any Junior Resident beyond one year of appointment under relaxed provisions.
- d. (i) Separate merit list for fresh candidates and relaxed candidates will be prepared.
  (ii) Firstly, the list containing names of fresh candidates would be exhausted for appointment as Junior Resident and second list would be used only after that, if required &fresh graduates are not available.

#### 8. Tenure:

The initial appointment is for 44 days, which can be extended for further 44 days till 01 year after receiving written request from the concerned doctor, which should be duly recommended & forwarded by the concerned HOD. The maximum tenure of Junior Resident Post is 01 year including the previous tenure served in any Govt. Hospital/institute/Organization. The ad-hoc appointment may be terminated earlier on the joining of Junior Residents on regular basis.

- Note 2: Candidates, who have already worked in any Govt. Hospital as Junior Resident (MBBS), the period as worked, will be counted to calculate the total period of Junior Residency.
- 9. The number of posts may vary as per incumbency position at the time of interview/declaration of result.
- 10. The applicants are required to fill their details online through Google Form available at the given link. The link of Google Form will be activated after approval of Medical Director, GTB Hospital and de-activated on 07.08.2025 at 02.00 P.M. The applicants should submit the duly signed copy of Google Form along with supporting documents at time of interview.
- 11. In case number of applications is high, the interview may be continued on the next working day(s). The same will be informed to candidates through E-mail.
- 12. No TA/DA will be paid to candidates for appearing in the interview.
- 13. The selection of candidates will be made on the basis of interview merit.
