A) Prescribed Qualification, Eligibility criteria, Age-limits/ निर्धारित योग्यता, पात्रता मानदंड,

आयु-सीमा

1. The candidate must possess requisite qualification as listed in the above table as on cut-off date.
2. Candidates possessing higher professional qualifications such as Diploma / B.E. or equivalent shall not be considered. Additionally, candidates having higher academic qualification like B.A./B.Sc./B.Com etc will not be given any additional weightage.
3. The age of the candidate should be maximum 21 years as on cut-off date. A relaxation of 5 years is admissible for SC/ST candidates and 3 years for OBC candidates in the upper age limit. All govt. guidelines on the matter will be observed.
4. **Cut-off date for eligibility criteria - 01.09.2025**

C) Stipend - As admissible under the rules.

D) Selection Methodology/ चुयन पद्धति – Selection for engagement of Apprentices would be based on written test.

E) How to Apply/ आवेदन कैसे करें

1) Candidates are advised to carefully read the full advertisement for details of educational qualifications and other eligibility criteria before submission of application.

2) Candidates shall ensure that Application form is neatly filled and all the documents are attached. Application with incomplete information and/or not accompanied with following documents are liable to be rejected and no correspondence in this regard will be entertained.

- a) True copies of all certificates/mark sheets/testimonials regarding age, qualifications, caste.
- b) AADHAR ID.

c) Candidates should register themselves through the website www.apprenticeship.gov.in and submit the registration ID proof.

d) The candidates who have passed ITI in 2023 and prior to the year 2023 will have to produce an affidavit on non-judicial stamp paper sworn-in before a Magistrate or Notary Public to the effect that they have neither undergone apprenticeship training from anywhere earlier nor have taken employment anywhere.

The candidate is advised to submit the applications well in advance without waiting for the closing date.
