^{*} As per Haryana Govt. Reservation Policy Notification No. 22/10/2013-1GSIII dated 15.07.2014, the vacancies are reserved for the category as shown in above table, but with the stipulation that in case no eligible candidate are available from the reserved category, the vacancies shall be filled up from the General Category on merit.
