# 3. Pay Scale:

Revised Pay Matrix Level-11 (Rs. 67700-208700/-), under CCS (Revised Pay) Rules, 2016 at the entry level. Allowances, as admissible, will be paid.

#### 4. Age Limit:

- a. Not exceeding 45 years (relaxation by 5 years for SC/ST, 3 years for OBC) on or before the last date of submission of application.
- b. Age relaxation of 10 years for Persons with Benchmark Disability (PwBD) for UR, 15 years for SC/ST and 13 years for OBC candidates.
- c. In case of Armed Forces candidates and widows, divorced women and women judicially separated from their husband, who are not married, the age relaxation will be given as per the instruction of Govt. of India time to time.

#### 5. Reservation:

All reservations will be considered in the above posts strictly in accordance with prescribed norms/rules

The Hospital will not be responsible for any Postal delay.

- d. Crucial date of determination of eligibility with regard to age and all aspects will be last date of submission of the application.

- v. The marks obtained by the candidates will be displayed on hospital web-site/notice board on the next working day after the screening test / written examination.
- vi. The list of qualified candidates (category-wise) for assessment will be displayed on Hospital web-site/notice board within three days of the screening test / written examination.
- vii. Candidates three times the number of vacancies (or less if not available) who qualify screening test will be called for assessment.
